

## Traffic Safety Regulations in the ISD Campus Parking Area

The following rules and regulations in the school's parking and access road will apply for all ISD families:

- 1. The maximum speed limit in the drop-off zone is **15** kilometers per hour.
- 2. Drivers must obey stop signs and directions by security and traffic personnel at all times.
- 3. The school campus access road is a one-way street with access only from Sayem Sobhan Anvir Road (Road 14). All vehicles will enter through Boom Gate no 1 and Pass through Boom Gate no 2.
- 4. Pedestrians will be given priority at designated crossing points at all times. Drivers must stop and allow pedestrians to cross at designated crossing points.
- 5. Weapons are not permitted in vehicles that enter the main campus access parking road. This applies to accompanying bodyguards in vehicles.
- 6. Students are not permitted to drive on the campus access parking road.
- 7. Only school-registered nannies and male family escorts are permitted to accompany or collect students on campus. Family employees will not be permitted to enter campus at drop off / pick up without school ID.
- 8. In the parking area, there are designated places for employed driver parking, ISD family parking, and ISD staff parking. It is forbidden to park vehicles outside designed these parking places,
- 9. Any public disturbance in the parking area involving drivers will immediately result in the revocation of parking rights for the vehicle.
- 10. Only school personnel, ISD family members, approved visitors and approved ISD family employees will be permitted to enter the main campus access parking road between 07:00 and 16:30.
- 11. Car users shall be liable for any damage caused by the user to school property, other car users, or towards third parties in the campus access road and parking area.
- 12. ISD shall not be liable for any damage resulting from force majeure, theft, destruction, or breakage of vehicles located on the school roadway and parking areas. The school shall also not be liable for any items left inside the vehicles.

- 13. The ISD campus parking zone is a smoking-free zone.
- 14. Vehicles not having authorized ISD Vehicle Sticker will not be allowed for parking.

## **Important Notes:**

- a. The school reserves the right to revoke access for drivers and vehicles that do not follow these traffic rules.
- b. The school also reserves the right to inspect vehicles that are suspected of violating the rule on the carriage of weapons or if random checks are considered necessary.
- c. The school can provide guidance to drivers to ensure their understanding of the rules if requested. However, it is the responsibility of families who employ drivers to ensure that they fully understand the school's driving regulations. A Bangla version of these regulations is also available.
- d. Failure to comply with these regulations may result in the cancellation of the enrollment agreement with the school.
